## Coverage Summary Voluntary Workers Personal Accidents Insurance

This coverage summary is attaching to and forming part of Policy No. 0034207. The Schedule and the Policy Wording (Accident and Health International Underwriting VWGPA PDS/WRD 01/14 ST) are to be read together as one contract.

This document summarises the coverage afforded. For full particulars including all conditions and exclusions, reference must be made to the current Policy wording.

Insured:

Non Members of The Federation of Parents & Citizens Associations including any member of the Named Insured whilst acting on behalf of the Named Insured.

Insurer(s):

Accident and Health International Underwriting

Covering:

This policy applies only in respect of voluntary workers and only whilst they are engaged on P&C Association activities.

The benefit is payable irrespective of negligence by the Non Member Association however the weekly benefit is only recoverable if the person loses time from work. In the case of a house person domestic expenses benefit becomes payable.

- (a) The injured person must be a voluntary worker acting on behalf of the Non Member Association Committee but does not preclude that person from suing the Non Member Association if negligence is proved.
- (b) There is no cover for children accompanying voluntary workers. For cover to apply they must be engaged in voluntary work on behalf of the Non Member Association.
- (c) Students over the age of 10 engaged in voluntary work on behalf of the Non Member Association must have written permission from a parent/carer to be covered by this insurance policy.
