ACNC - Helping P&C Associations

The ACNC is running a special free webinar on 21 March 2017 designed for school P&C associations. As you are a representative body for school P&C associations, we would like to send you the details of the webinar and ask that you pass them on as an invitation to your member associations.

The webinar will begin at noon on Tuesday 21 March 2017 and will run for approximately 45 minutes to 1 hour. It is aimed at helping school P&C associations understand what it means to be registered as a charity with the ACNC.

- why a P&C association may be registered as a charity with the ACNC
- the benefits of being registered
- what a registered P&C association has to do

Attendees will be able to ask questions of ACNC staff throughout the webinar.

Is your P&C Association complying with the ATO?

P&C Associations should take care to ensure they are complying with their tax and super obligations as not-for-profit (NFP) organisations.

Australian Taxation Office

Penalties for non-compliance may include revoking entitlement to tax concessions, raising tax liabilities or applying interest to unpaid liabilities.

Some activities that may result in penalties include:

1. Late lodgment of annual return
2. Applying P&C income and assets to individuals.
3. Incorrectly advertising that donations are tax deductible when your P&C Association is not endorsed as a deductible gift recipient.
4. Incorrectly self-assessing income tax exempt status or not meeting the requirements of an exempt category 5.
5. Incorrectly claiming Fringe benefits tax rebates and exemptions that don't meet the requirements of the law 6.
6. Incorrectly classifying member and non-member income and expenses which may result in an understatement of assessable income

If a mistake was made when giving the ATO information about tax affairs, your P&C Association can make a voluntary disclosure. If you find a mistake, a voluntary disclosure should be made as soon as possible.

Affiliate Email Account
