The Parent and Citizen Journal is printed quarterly with a typical print run of ~6,000. Copies are distributed directly to P&C Associations in every public school in New South Wales as well as government organisations, educational institutions and private subscribers. 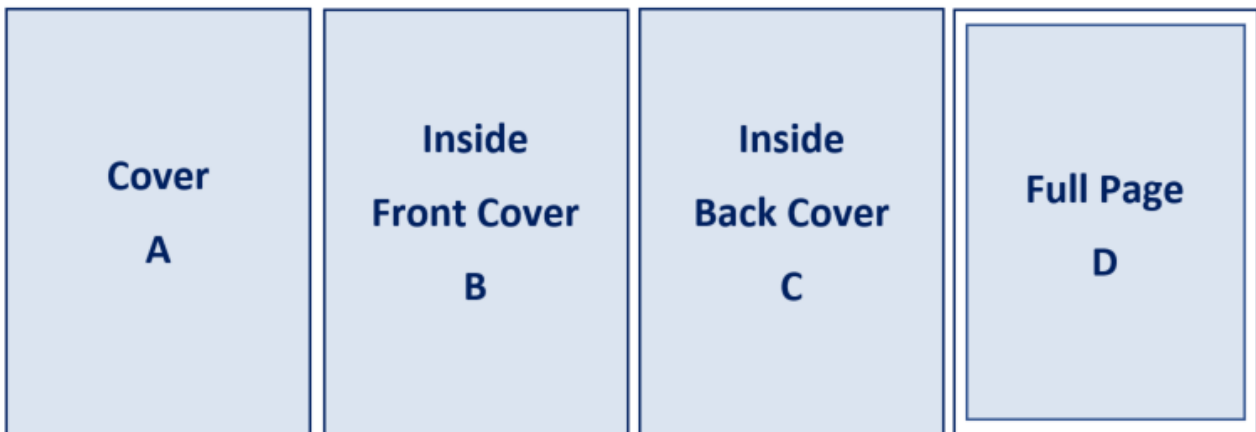

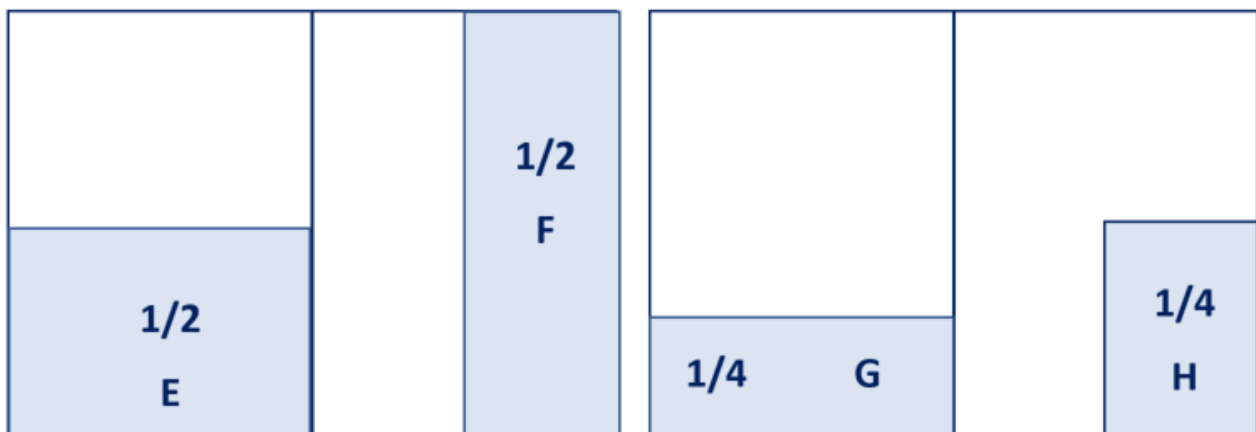
